
### **NBFE Unveils CFMHE Locator Map**



At the request of attorneys who wanted a more convenient option for locating a CFMHE in their area, NBFE has launched a new tool our website that allows referral sources to locate CFMHEs by geographical location. Site visitors can click on any CFMHE and read additional information, including what types of forensic evaluations the CFMHE specializes in. *Use this new benefit to its maximum potential by addressing the following recommendations:*
